

**General Guidelines on Transfer and Posting**

- Transfer and Posting will be proposed by the appropriate Boards constituted for the same, the details of which are given in **Annexure**.
- Since the office is organised into different functional groups, the Board will be recommending postings to a Group. Once posted, an official under normal circumstances would have a minimum tenure of two years. Exceptions may be made on compassionate grounds or on account of administrative exigencies. While making such exceptions to the general norm, the concerned Board would record in writing the circumstances which necessitated the transfer before two years.
